

## **2007 EXTENDED CARE CAMPERS TRANSPORTATION**

**If your Child is in extended care both AM and PM follow this procedure:**

**EXTENDED CHILD CARE:** 8 a.m.-9 a.m. and 3:15 p.m. to 6 p.m. extended childcare is available; go to the **REGISTRATION TAB**.

**Drop off and Pick up procedures for Extended Care only:**

AM Drop Off – PM Pick Up

Park in the Staff Parking Lot (there will be a sign on Bowker Street). Walk up the path to meet the Day Care Staff at the Table to sign your child in and sign them out in the afternoon.

**If you camper is in extended care for only AM or only PM and you are providing the transportation at the regularly scheduled camp time (either 9AM and/or 3:15 PM) you will need to follow a combination of the above and the below:**

**Morning Drop Off 8:45- 9am:** There is **NO PARKING** on **BOWKER** Street. To drop off your children **ENTER Bowker Street FROM Route 123 (Main Street)**. When you reach camp a staff member will take your attendance form and unload your children. You can download attendance forms from our web site **[www.meadowcroftcamp.com](http://www.meadowcroftcamp.com)** under **Camp Forms Tab** and/or you will be given a supply of forms on your first day.

If you need to go to the office, etc., pull into the Kelly's house driveway (last driveway on the right at the end of Bowker Street) and park between the trees; **do not block the driveway. Please do not drop your child off before 8:45 a.m.**

**please, do not turn around in our neighbors' driveways and please drive slowly on bowker street.**

**Afternoon Dismissal 3:15 P.M.:**

The Town of Norwell has requested that we restrict the number of cars on Bowker Street for the afternoon dismissal of campers. Hence, if you are a parent driving your child, you must meet your child at the following shuttle spots each afternoon: (Shuttle busses will arrive at these points **between 3:20 and 3:30 PM**).

**If you live in the TOWNS OF:**

Norwell, Hanover, Rockland, Marshfield, Pembroke, Duxbury, Halifax, Milton, Plymouth, Kingston, East Bridgewater, Holbrook, Abington, Hanson, Norton.

**Your afternoon pick up will be at:**

**UNITED CHURCH OF CHRIST; (460 MAIN STREET) - ROUTE 123 Norwell**

**Please tell your child he/she should be on the Norwell shuttle bus.**

**If you live in the TOWNS OF:**

Scituate, Cohasset, Humarock.

**Your afternoon pick up will be at:**

**SCITUATE HIGH SCHOOL (Route 3A)**

**Please tell your child he/she should be on the Scituate shuttle bus.**

**If you live in the TOWNS OF:**

Hingham, Weymouth, Hull, Braintree, Quincy, Boston, Milton.

**Your afternoon pick up will be at:**

**SOUTH SHORE BAPTIST CHURCH, HINGHAM;** (Main and Free Street)

**Please tell your child he/she should be on the Hingham shuttle bus.**

Please remain in your car until the buses have unloaded the children. The parking lot monitors will be certain that a parent is present to pick up each child; if you are not there at 3:45 p.m. your child will be returned to camp. Please allow the bus to leave the parking lot before you exit. It is imperative that the buses stick to their schedule and they cannot wait for the parents to leave.

**If you have paid for BUS transportation either AM or PM you will receive a time and meeting point.**

Bus transportation is only available for the regularly scheduled camp hours. For the extended hours you must provide your own transportation.
